*Administrators should register staff. *Pls. make sure that the staff has completed the DSP-1 training before taking DSP-2.*

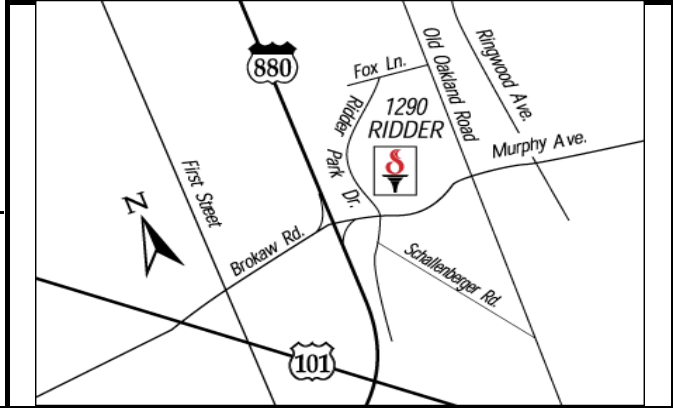
*Call at least one week in advance to cancel.
